The above order will be followed the day of the pageant. Contestants should arrive dressed and check in by their assigned time. This will ensure the pageant is able to run smoothly and continually.

0-12 Baby Miss will take the stage first, 0- 12 Baby Master will be in holding area 1 and 13-24 month Wee Miss will be in holding area 2. Each contestant will be announced individually and exit to holding area 3, after the last contestant in that category exits the stage, all

contestants in that category will re-enter the stage area in order for a final viewing by the judges and then exit to holding area 4 to wait for results. The group in holding area 1 will then take the stage one contestant at a time, exit to holding area 3 and re-enter the stage as a group after the final contestant in that category. Contestants will exit to holding area 4, as contestants in holding area 4 retake the stage for crowning and the cycle will repeat.

If there are no entries in a category, it will be omitted and the next age group will compete during that time.
